- (ii) Certificate of Compliance issued in accordance with the National Insurance Act

The original and one (1) copy of the completed prequalification application must be placed in a sealed envelope addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and clearly marked on the outside:-
