Sealed tenders in **TRIPLICATE** on the approved Tender Form will be received not later than **1.00 pm on Thursday August 14, 2014.**

Envelopes must be addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and must be deposited in the **BROWN** Tenders Box located in the lobby of the Board's Office.
