A pre-tender meeting followed by site visits will be held for prospective tenderers at the Sangre Grande Regional Corporation, Chamber Hall, Ramdass Street, Sangre Grande on **Monday August 18, 2014 at 10.00 a.m.**

Tenders must be accompanied by:-

- (i) valid **Income Tax and Value Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) valid **Certificate of Compliance** issued in accordance with the National Insurance Act.

The **original tender and three (3) copies each** must be placed in sealed envelopes, addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and **clearly marked** on the outside:-

“Tender for Road Paving Works for the Sangre Grande Regional Corporation, Ministry of Local Government”

Envelopes must be deposited in the **BROWN** Tenders Box located in the lobby of the Board's Office not later than **1.00 p.m. on THURSDAY AUGUST 28, 2014.**

Tenders will be opened shortly thereafter. The tenderer or an authorized representative may be present at the opening.

Late tenders **will not** be considered in any circumstances.
