## \$4B Public Sector Back-pay

The Minister of Finance and the Economy wishes to correct some misconceptions which may have arisen as a consequence of an article which appeared on page A5 in the August 7<sup>th</sup> 2015 issue of the Guardian newspaper and headlined "\$4b in backpay come November"

1. The \$4B back-pay covers payments to many categories of Public Sector workers and not just nurses and RHAs. This includes, Teachers, the Civil Service, the Protective Services and employees of the following:

Statutory Boards and Similar Bodies not subject to the Statutory Authorities Act, but in respect of which the Personnel Department had traditionally exercised or had responsibility for the classification and compensation of offices:

- 2. Some public sector workers would have received their back-pay at the end of July 2015 while others will receive theirs at the end of August 2015.
- 3. Back-pay for the RHAs will be paid in November 2015.
- 4. Subsequent to completion of these negotiations, CPO Stephanie Lewis went on preretirement leave. Beresford Riley is now the Acting CPO.
